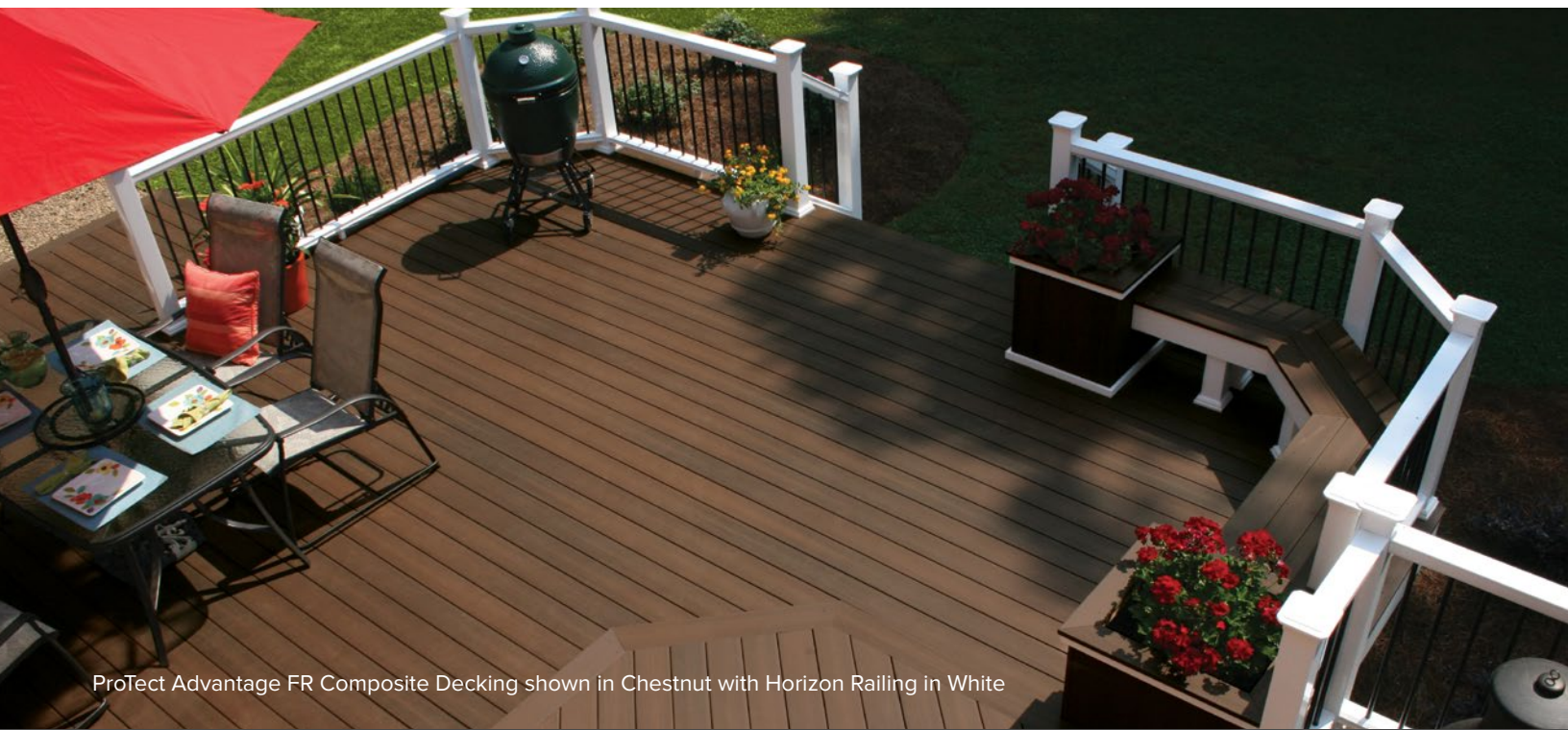

What You Need To Know About California's New Building Codes
