APPLICATION INSTRUCTIONS

SURFACE PREPARATION

The surface to receive TW-105 Flashing must be clean, dry and have a smooth finish. Note: Flash or Fill any gaps in or between substrates greater than 1/2" with appropriate material such as metal flashing, non-shrink grout, backer rod, etc.

Priming.

Priming is required for all applications. Prime with TAMKO TWP-1 Primer*** or TWP-2 Water-Based Primer as appropriate for the surface to be primed.

***WARNINGS AND HAZARDS

TWP-1 Primer contains combustible solvents. Avoid exposure to sparks, open flame, heat, and other forms of ignition. Use in well-ventilated areas. Avoid breathing vapors. FLASHING APPLICATION

Install TW-105 Flashing at wall/floor intersections and other transition locations. TW-105 Flashing must not be exposed to ponding water. Refer to Construction Detail on second page of application instructions or the "TAMKO Waterproofing Construction Detail TW-14", which is available online at tamko.com. Apply when temperature is 35° F or above during the entire installation. Side laps must be 2-1/2", and end laps must be 5" and lapped the direction of water flow. Apply TAMKO TWM-1 Mastic at all terminating edges. Membrane must not be left exposed to sunlight for more than 30 days.

Warning: Failure to use adequate pressure at terminating edges will result in poor seal, potential leaks and may affect coverage under the limited warranty which can be found at tamko.com or by calling 800-641-4691. The use of mastic is not a substitute for a good seal.
